Introduction: About Affordable Rental Housing



Affordable housing refers to housing that is reasonably priced for individuals or families with very low to moderate incomes. The definition of “affordable” housing is that the cost of rent should not exceed a certain percentage of a household’s income, typically 30% to 40%, including utilities. This ensures that people can afford other basic living expenses such as food, healthcare, and transportation.

Ongoing rental assistance programs are designed for individuals and families that meet income eligibility guidelines. Many local rental assistance programs and affordable housing options are available to help you search for what meets your needs.

Housing agencies go by different acronyms depending upon the services offered to the public, but each offers some type of rental assistance.

TERMS USED IN THIS BOOKLET

Area Median Income (AMI)	Refers to the middle-income level for a specific region, meaning exactly half of the families in that area earn more and half earn less.
Fixed-rent	Refers to an unchanging amount of rent for a specified period, regardless of changes in market conditions. Rent for these types of units is not income-based.
Income-based	These are rental units in which rent is determined by the income of the tenant. For example, the rent may be 30% to 40% of income. If the tenant's income changes, the rent may also change.
Market rate/conditions	Refers to rent amounts that are based on the current local demand and availability, amenities, building age and condition, unit size, and so forth.
Private market	Refers to a unit available for rent that is owned by an individual or business.
Project-based	These are rental units built and managed as part of a specific development, often with government subsidies, to provide low-income individuals or families with stable, affordable housing.
Public housing	Refers to government-owned housing. The rent is income-based, and the subsidy stays with the unit.
Section 8/Housing Choice Voucher (HCV)	This is a federal program in the U.S. that provides rental assistance to low-income families by subsidizing a portion of the rent.
Subsidized	In housing, "subsidized" means a government-sponsored program that helps low-income people pay for rent. The government directly pays landlords to reduce rent for tenants with low incomes.
Tax-credit property	This is a housing unit built or renovated with the help of Low Income Housing Tax Credits (LIHTC), which provides tax incentives to developers in exchange for offering affordable rents to low-income tenants.
Voucher	A type of public assistance for rental housing. The government pays a subsidy directly to the landlord, and the tenant pays the remaining balance.

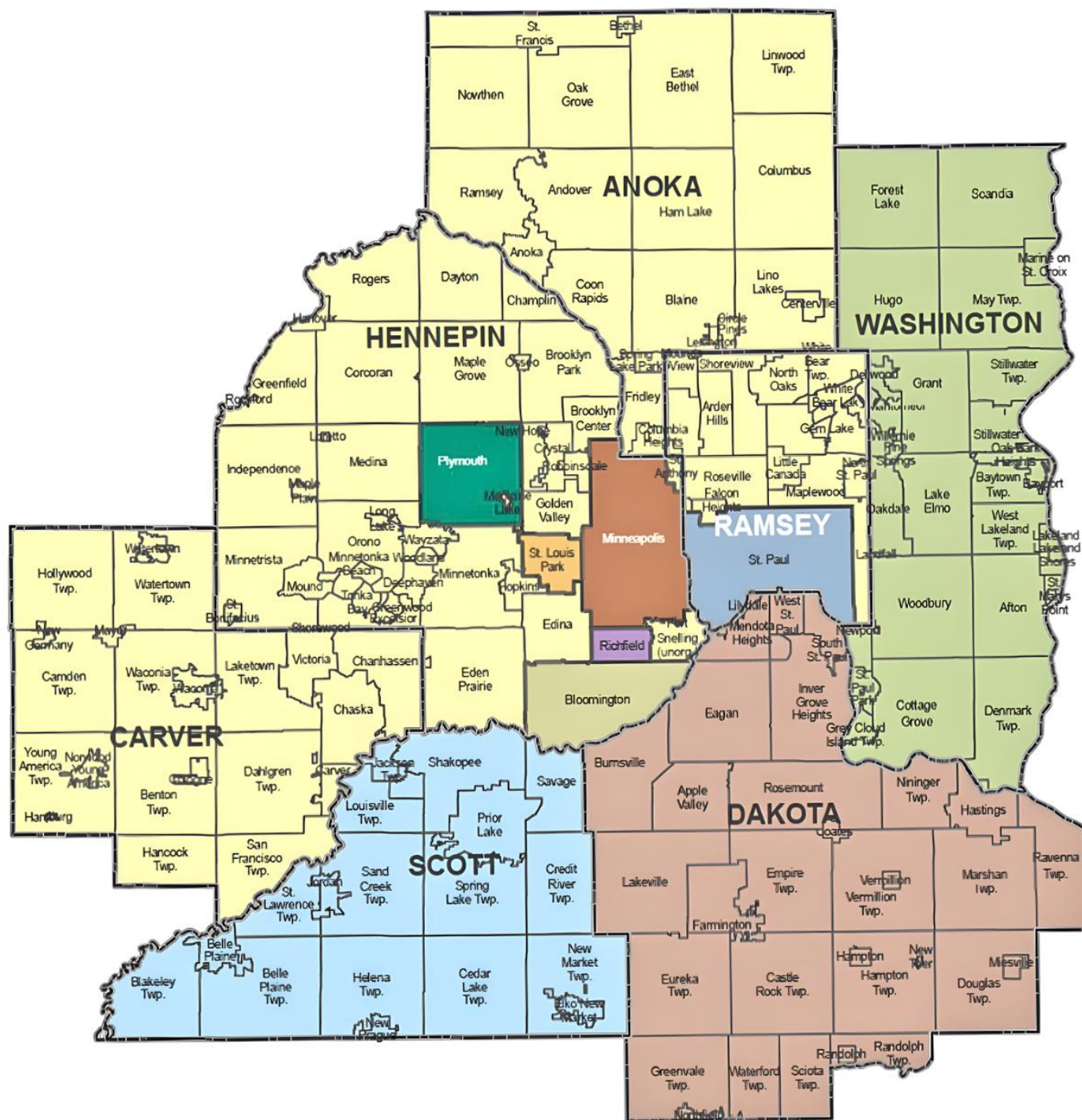
If you already have a Section 8 Voucher and are transferring, or "porting," to Washington County:
